Dear Food Vendor:

Attached are information and an application for the 2011 Market Days, a premier arts and crafts show. The dates for this year's show are **December 3 and 4, 2011**.

Market Days began 42 years ago and due to its rapid growth, moved to the North Florida Fairgrounds in 1969. Last year more than 14,000 people attended this two-day event and craft sales totaled more than three-quarters of a million dollars. Market Days benefits the Tallahassee Museum of History and Natural Science.

The Tallahassee Museum is a 51-acre facility that includes a diversity of permanent exhibits; Natural habitats for indigenous and rare wildlife including the Florida panther and red wolf, nature trails; and, a working 19<sup>th</sup> century farmstead. In addition, there are contemporary exhibit galleries and historic structures including an antebellum plantation house, a one-room schoolhouse, a rural church and wooden caboose. The Museum offers classes and tours for schools and other educational groups, and last year alone served more than 35,000 students. It also provides a wide diversity of educational programs in history and natural science. The Museum is one of the state's leading museums and is nationally accredited by the American Association of Museums.

If you decide to apply, **the application and fees must be received by October 21, 2011**. Please attach a copy your state health permit with your application if you already have one issued. The decision will be mailed, October 22, 2011. If you fail to get a response by October 29th, please email or call. We look forward to hearing from you.
